But do remember that if you want to make an over the counter tax payment in cash, the challan amount cannot exceed ₹10,000

Under Pre-Login section, customers can make Tax payments for PAN/TAN for a maximum of 5 transactions. To make unlimited transactions, customer should login to the E-Filing portal.

For Corporate entities, the checker should approve the transaction on Net Banking for completing the transaction.
